

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

iShares STOXX Global Select Dividend 100 UCITS ETF (DE) (the “Fund”), ISIN: **DE000A0F5UH1**, is authorised in Germany and manufactured by BlackRock Asset Management Deutschland AG (the “Manager”) which is part of the BlackRock, Inc group.

The Manager is authorised in Germany and regulated by the Federal Financial Supervisory Authority (BaFin) and BaFin is responsible for supervising the Manager in relation to this Key Information Document.

What is this product?

Type: The Fund is a sub-fund of iShares (DE) I Investmentaktiengesellschaft mit Teilgesellschaftsvermögen, an umbrella company incorporated in Germany authorised by the Federal Financial Supervisory Authority as a Undertaking for Collective Investment in Transferable Securities (“UCITS”). The Fund is a UCITS exchange-traded fund, a UCITS ETF.

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be terminated unilaterally by the Manager following reasonable prior notice to unitholders, subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The sub-fund iShares STOXX Global Select Dividend 100 UCITS ETF (DE) (the “Fund”) is a passively managed exchange traded fund (ETF) that aims to track the performance of the STOXX® Global Select Dividend 100 Index. In this regard, it aims to replicate the benchmark (Index).
- The Index measures the performance of 100 leading stocks by dividend yield from the STOXX® Europe Select Dividend 30 index, the STOXX® North America Select Dividend 40 index and the STOXX® Asia/Pacific Select Dividend 30 index that meet specific criteria. The Index includes companies which, at the time of inclusion, have paid dividends in four out of five calendar years, have a non-negative dividend growth rate over the past five years, have a dividend to earnings-per-share ratio of 60% (80% for Asia/Pacific) or less, and meet criteria for trading volume. The Index is weighted according to net dividend yield with individual companies capped at 10%. The Index is rebalanced annually and selections of components are subject to index rules that favour components within the Index prior to its rebalance. In addition, the Index is subject to quarterly and ongoing reviews that allow for the removal of a company, at the index provider's discretion, if it no longer complies with the original selection criteria.
- The Fund mostly invests in equities in order to achieve the investment objective.
- The proportion of assets in the Fund which matches the weighting of the Index (duplication percentage) is at least 95% of the Fund's assets.
- It is not the Investment Manager's intention to leverage the Fund. However, the Fund may generate minimal amounts of leverage from time to time, for example, if using financial derivative instruments (FDIs) for efficient portfolio management purposes.
- The price of equity securities fluctuates daily and may be influenced by factors affecting the performance of the individual companies issuing the equities, as well as by daily stock market movements, and broader economic and political developments which in turn may affect the value of the investment.
- The relationship between the return on the investment, how it is impacted and the period for which you hold the investment is considered below (see “How long should I hold it and can I take my money out early?”).
- The depositary of the Fund is State Street Bank International GmbH.

- Your shares will be distributing shares (i.e. dividend income will be paid at least annually).
- The Fund's base currency is Euro.
- The shares are listed on one or more Stock Exchange(s). Investors can buy or sell their shares daily during business hours through an intermediary on such Stock Exchange(s). The value of the shares is related to the value of the underlying assets of the Fund, less costs (see “What are the costs?” below). The prevailing market price at which the shares trade on the secondary market may deviate from the value of the shares. Indicative net asset value is published on relevant stock exchanges websites.

Intended retail investor: This Fund is intended for retail investors with basic knowledge and experience, with the ability to bear losses up to the amount invested in the Fund. This Fund is suitable for medium to long term investment, though the Fund may also be suitable for shorter term exposure to the Index (see “How long should I hold it and can I take my money out early?”).

Insurance benefits: The Fund does not offer any insurance benefits.

What happens if BlackRock Asset Management Deutschland AG is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary, State Street Bank International GmbH (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations). As an investor in the Fund you would not be able to make a claim to any compensation scheme about the Fund in the event that the Fund is unable to pay out.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time: The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return).
- For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early? Recommended Holding Period: 5 years

The Company may suspend the issue and redemption of shares if exceptional circumstances make this necessary, taking into account the interests of investors. In order to manage liquidity risks, the Company may use liquidity management tools (LMTs) disclosed in the prospectus such as restriction of redemption where investors' redemption requests reach a predetermined threshold above which the redemption requests can no longer be executed in the interest of all investors, or extend the redemption period for shares. The Company may also use other procedures that are disclosed in the prospectus such as, for example, charging a redemption fee, anti-dilution fee, swing pricing or dual pricing, whereby the costs incurred by issue and/or redemption (e.g. transaction costs) are distributed to investors that trigger such activity, thereby reducing the risk of dilution for the investors remaining in the fund. The Company may spin off illiquid assets in the interest of investors. Further details on applicable LMTs can be found in the prospectus.
